AMENDMENT TO DECLARATION OF COVENANTS AND RESTRICTIONS FOR KENDALL CREEK

THIS AMENDMENT TO DECLARATION OF COVENANTS AND RESTRICTIONS FOR KENDALL CREEK ("Amendment") is made effective April 2015, by GREENBRIAR HOLDINGS, LLC, a Florida limited liability company (the "Developer").

RECITALS:

- A. The Declaration of Covenants and Restrictions for Kendall Creek dated February 6, 2015 is recorded in Official Records Book 3985, beginning at page 1897, of the public records of St. Johns County, Florida (the "Declaration").
- B. In accordance with the Developer's unilateral right to amend the Declaration as set forth in Section 13.5 of the Declaration, and further to facilitate the continuation of the common scheme of development evidenced by the Declaration and the plats and other documents referenced therein, Declarant desires to amend the Declaration as more particularly described hereafter.

NOW THEREFORE, the Declarant hereby amends the Declaration as follows:

- 1. The Declarant hereby confirms the above-stated recitals are true and correct. To the extent not otherwise defined herein, all capitalized terms contained in this Amendment shall have the same meanings as such terms are defined by the Declaration.
- 2. The heading on Page 1 of the Declaration, Official Records Book Book 3985, Page 1902 is hereby deleted and replaced with the following:

DECLARATION OF COVENANTS AND RESTRICTIONS FOR KENDALL CREEK

- 3. The first sentence of Article II, Section 2.1, of the Declaration is hereby amended in its entirety as follows:
- "Association" shall mean Kendall Creek Owners Association, Inc., a Florida corporation not-for profit.
- 4. The first sentence of Article II, Section 2.4, of the Declaration shall be deleted and replaced with the following:

Greebriar Holdings, LLC, a Florida limited liability company, and its successors and such of its assigns as to which the rights of the Developer hereunder are specifically assigned.

- 5. Article II, Section 2.9, of the Declaration is hereby deleted and replaced with the following:
- Section 2.9 PUD. Planned Unit Development Ordinance Number 2013-02, as enacted by St. Johns County, Florida, as the same may be amended from time to time.
 - 6. The following changes are made to Article VII, Section 7.2.1:
- a. In the next to the last sentence of Article VII, Section 7.2.1, the Surface Water Permit number shall be 40-109-134997-2. Reference to 40-109-134437 is hereby deleted.
- b. The last sentence of Article VII, Section 7.2.1, is hereby deleted and replaced with the following:

Assessments collected by the Association to fund reserves, if any, shall be collected for, and disbursed, as required by law, including without limitation, Section 720.303, Florida Statutes, as the same may be amended from time to time.

- 7. Article X, Section 10.2, of the Declaration is hereby amended in its entirety as follows:
- Section 10.2 Living Area. Each detached single family residence constructed upon a Lot shall contain a minimum of two thousand (2,000) square feet of heated and air conditioned living area.
- 8. The first sentence of Article X, Section 10.22 of the Declaration is hereby amended in its entirety as follows:
- Section 10.22 <u>Jurisdictional Areas and Permits</u>. THE PROPERTY HAS BEEN OR WILL BE DEVELOPED IN ACCORDANCE WITH ANY APPLICABLE PERMITS ISSUED BY THE ACOE AND PERMIT NUMBER 40-109-134997-2 ISSUED BY THE SJRWMD (THE "PERMITS").
 - 8. Add the following new Section 10.24 to Article X of the Declaration:
- 10.24 <u>Sidewalks</u>. The Owner of a Lot building a residential dwelling unit on such Lot shall be responsible for constructing a sidewalk on or in front of such Lot, in accordance with the subdivision construction plans submitted to and approved by St. Johns County (the "Plans"). Such sidewalk shall be completed in accordance with the Plans prior to the issuance of a certificate of occupancy for a dwelling unit on a Lot.

9. Exhibit "B" of the Declaration is hereby replaced with the Exhibit "B" attached hereto.
